



THE UNDERSIGNED Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation shall be:

The corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.


