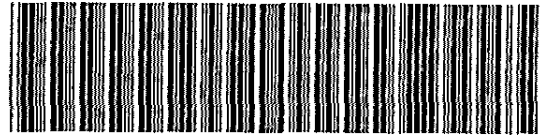

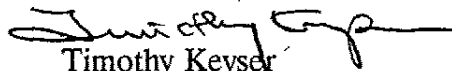

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME**

The name of the Corporation ("Corporation") is **JWALKER, INC..**

**ARTICLE II - DATE**

The existence of the Corporation shall begin on 15 October 2004.

**ARTICLE III - ADDRESS**

The street address of the principal office of the Corporation is Post Office Box 92, 501 Atlantic Avenue, Interlachen, Florida 32148.

**ARTICLE IV - SHARES**

The maximum number of shares this Corporation is authorized to issue is 100 with no par value. All of which shall be common shares.
