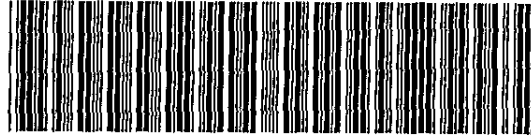



WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLE I, NAME

The name of this corporation shall be:

The power to adopt, alter, amend, or repeal by-laws shall be vested in the Board of Directors and Shareholders.


ARTICLE X. AMENDMENT
