

The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Gale Lazarus, P.A.

ARTICLE II

GENERAL NATURE OF BUSINESS

The primary purpose for which this corporation is organized is to sell real estate and transact any and all lawful business for which corporations may be organized under the laws of the State of Florida, and to have all powers which are afforded to corporations under the laws of the State of Florida.


