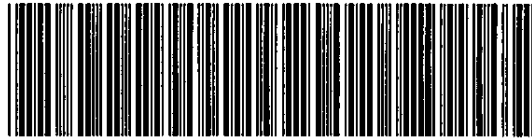

Pursuant to the provisions of Florida Statutes Section 607.1006, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The Articles of Incorporation were filed on October 18, 2004. The document number for this entity is P04000143722.

**SECOND:** The following amendment and restatement of Article I of the Articles of Incorporation is adopted by the Professional Service Corporation:

**ARTICLE I. Name**

The name of the Professional Service Corporation is: "Fowler & Associates, P.A."

**THIRD:** The following amendment is added as Article VIII of the Articles of Incorporation by the Professional Service Corporation:

**ARTICLE VIII. Purpose**

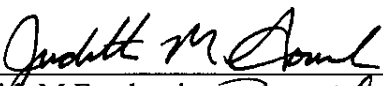
The general purpose for which this Professional Service Corporation is organized:
