The undersigned, desiring to organize a corporation under the Florida Business Corporation Act, Florida Statutes, Chapter 607, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME & PRINCIPAL OFFICE**

The name of the corporation is FIGUEIRA CORPORATION ("Corporation") and its principal business address is 408 N. Perry Avenue, Jupiter, Florida 33458.

**ARTICLE II
DURATION**

This Corporation shall have perpetual existence.
