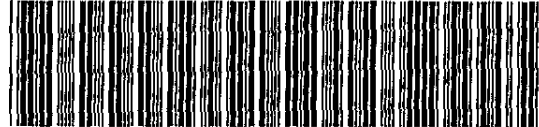

**ARTICLES OF INCORPORATION
OF
COSMO GRAPHICS, INC.**

ARTICLE I - NAME

The name of the corporation is COSMO GRAPHICS, INC. (hereinafter called the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 13586 Kiltie Court, Delray Beach, Florida 33446.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for corporations organized under the Florida Business Corporation Act.

ARTICLE IV - DURATION

The Corporation shall have perpetual existence.

ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 10,000 shares of Common Stock, par value \$1.00 per share.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

Michel A. Breton is the initial director of the corporation holding the office of both President and Secretary at his address of 13586 Kiltie Court, Delray Beach, Florida 33446. The number of directors may be either increased or decreased from time to time, as provided in the Bylaws of the Corporation.

ARTICLE VII - SHAREHOLDER QUORUM AND VOTING

A majority of the Shareholders of the Corporation shall constitute a quorum at a meeting of the Shareholders. If a quorum is present, the affirmative vote of a majority of the shares represented at the meeting and entitled to vote shall be the act of the Shareholders.

ARTICLE VIII - ARTICLES OF INCORPORATION

The power to adopt, alter, amend or repeal these Articles of Incorporation shall rest with the Shareholders at a Shareholders' meeting.

ARTICLE IX - BYLAWS

The power to adopt, alter, amend or repeal the bylaws of the corporation shall be vested in the Board of Directors.

ARTICLE X - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE XI - INCORPORATOR
