ARTICLES OF INCORPORATION OF BW PAQUETTE CONSTRUCTION, INCREES OF DESCRIPTION O

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of the corporation ("Corporation") is BW Paguette Construction, Inc.

ARTICLE II - TERM OF EXISTENCE
