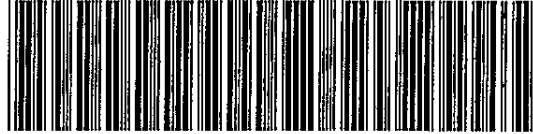




ARTICLE X SPECIAL PROVISION
