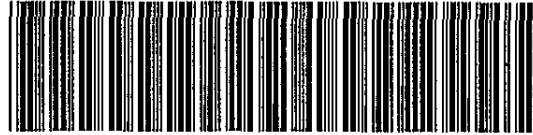

The undersigned, acting as incorporator of a corporation under the FLORIDA General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**  
**NAME AND PRINCIPAL OFFICE**

The name of this corporation is KOST ENTERPRISES, INC and its principal office is located at 1139 Oriole Beach Road, Gulf Breeze, Florida 32563 and its mailing address is 1139 Oriole Beach Road, Gulf Breeze, Florida 32563.

**ARTICLE II**  
**DURATION**

This corporation shall exist perpetually.

**ARTICLE III**  
**PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of FLORIDA.

**ARTICLE IV**  
**CAPITAL STOCK**
