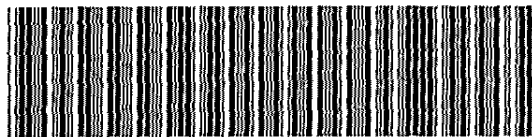

NAME

The name of this corporation is Kevin Peters Fence Depot, Inc.

ARTICLE II
