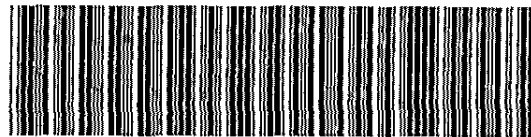

ARTICLES OF INCORPORATION

OF

JPR Designs, Inc.

ARTICLE ONE

The name of this corporation is JPR Designs, Inc. and the mailing address of the corporation shall be 3702 Edgewater Drive, Orlando, FL 32804.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:
