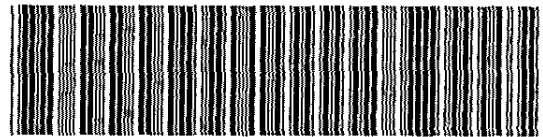

The undersigned Subscribers to these Article of Incorporation, natural person to contract, do hereby form a corporation for profit under the laws of the State of Florida.

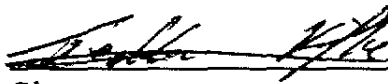
