

ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

NoSo, Inc.

The undersigned, acting as the Incorporator of NoSo, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

### ARTICLE I - NAME

The name of the Corporation is NoSo, Inc. The street and mailing address of the Corporation shall be 3801 Norbury Court, Orlando, FL 32835.

#### ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

#### ARTICLE III - DURATION

The Corporation shall exist perpetually.

#### ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

#### ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock having a par value of one cent (\$0.01) per share.

### <u>ARTICLE VI – ISSUANCE OF ADDITIONAL SHARES</u>

All rights conferred to issue additional shares of stock under Section 607.0621 of the Florida Statutes shall be reserved to the Shareholders.

#### <u>ARTICLE VII - PREEMPTIVE RIGHTS</u>

The corporation elects to have preemptive rights in accordance with Section 607.0630 of the Florida Statutes.

### ARTICLE VIII - INITIAL REGISTERED OFFICE AND AGENT
