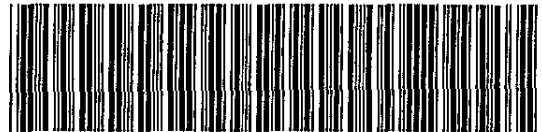


ARTICLE XII


