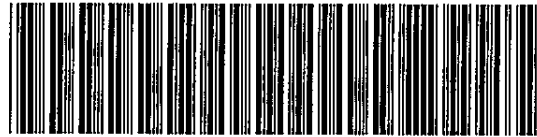

**ARTICLES OF INCORPORATION
OF
CARBIN ENTERPRISES, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is CARBIN ENTERPRISES, Inc., and the principal address and principal place of business is 8200 Bryan Dairy Road, Suite 300, Largo, Florida 33777.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE III - PURPOSE

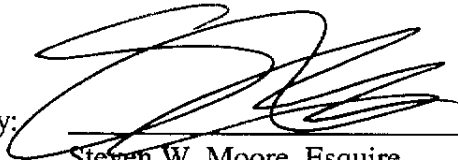
ARTICLE VI - AMENDMENTS

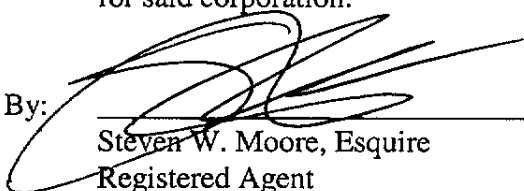
