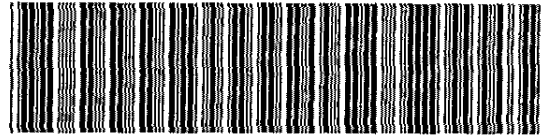

UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE
