## ARTICLES OF INCORPORATION OF MEAT DEPOT, INC.

The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Floridation

# ARTICLE I - NAME -

The name of this corporation is MEAT DEPOT, INC.

#### ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

#### ARTICLE III - CAPITAL STOCK
