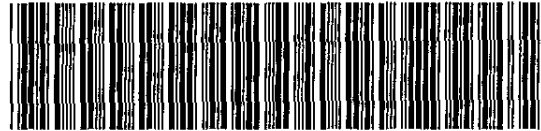


1. The name of the corporation is JESSIE'S MOVING & DELIVERY SERVICE, INC.
