# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

# Article I

#### Name

The name of the corporation is Sasha Stewart, P.A., and the principal address shall be, 3255 NE 184th Street, Apt. 12207, Aventura, FL 33160.

#### Article II

#### Duration
