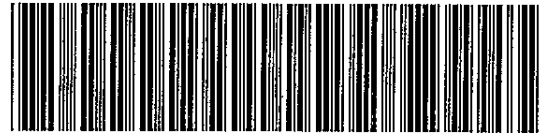

This corporation is organized for the purpose of transaction of any or all lawful business permitted under the laws of the State of Florida.


Article IV - Capital Stock
