## ARTICLES OF INCORPORATION OF FLORIDA HIGH QUALITY MOVERS, INC.

The undersigned, for purposes of forming a corporation under the Florida Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE ONE

The name of the Corporation shall be Florida High Quality Movers, Inc.

#### ARTICLE TWO

This Corporation shall have perpetual existence.
