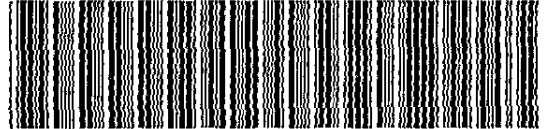

ARTICLE I - CORPORATE NAME

The name of this corporation is PRIME MERIDIAN COMMUNICATIONS, INC., whose initial principal office address is 1927 Matte Drive, Melbourne, Florida 32935 and whose mailing address is 1927 Matte Drive, Melbourne, Florida 32935.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

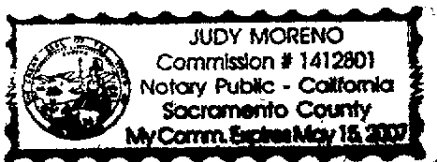
