ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the "Florida Business Corporation Act," does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is P, Y & V, Inc.

ARTICLE II

The principal place of business and mailing address of this Corporation shall be:

ARTICLE III

The general nature of the business to be transacted by this Corporation is to engage in F any and all business permitted under the laws of the State of Florida.
