ARTICLES OF INCORPORATION OF:

JAX COAST CORPORATION

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 609 of the Florida Statutes.

ARTICLE IX POWER OF CORPORATION
