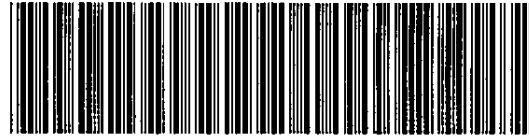

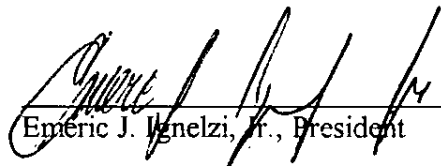

## ARTICLES OF DISSOLUTION
