ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation,

Article 1 - Name and Address

The name of this Corporation is 6840 114th, Inc. The principal place of business of this Corporation shall be 6840 114th Ave. North, Largo, Florida 33773, or such other place as may be designated by the Board of Directors.

Article 2 - Commencement of Business

The Corporation shall commence as of filing and shall continue to exist perpetually.

Article 3 - Capital Stock

The Corporation shall have the authority to issue 1,000 shares of common stock, no par value.

Article 4 - Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 6840 114th Ave. North, Largo, Florida 33773. The initial registered agent of this Corporation is Michael A. Menchen.

Article 5 - Incorporator

The name and address of the person signing these Articles as the incorporator is Michael A. Menchen, 6840 114th Ave. North, Largo, Florida 33773.

Article 6 - Cumulative Voting

At all times, each Shareholder of the Corporation who is entitled to vote shall have one vote for each share having voting rights and standing in the Shareholder's name on the Corporation's books. In elections for the Board of Directors, each Shareholder entitled to vote shall be allowed to cumulate their votes for directors thereby allowing them to have a number of votes equal to the number of voting shares held by the Shareholder multiplied by the number of Directors that the Shareholders may elect. The Shareholder may cast all such votes for a single candidate or may distribute them among some or all of the candidates.

Article 7 - Preemptive Rights

The Stockholders of the Corporation shall have the preemptive right to subscribe for and purchase their proportionate shares of any additional stock issued by the Corporation, from and after the issuance of the shares originally subscribed for by the stockholders of this Corporation, whether such additional shares be issued for cash, property, services or any other consideration, and whether or not such shares be presently authorized or be authorized by subsequent amendment to these Articles of Incorporation.

Article 8 - Initial Officers


The initial officers of this Corporation shall be Michael A. Menchen as the President, Secretary, and Treasurer.
