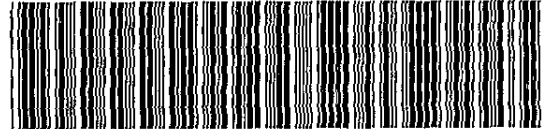

**ARTICLE I. NAME.**

The name of this Corporation is: REBAR ENTERTAINMENT, INC.

**ARTICLE II. PURPOSE.**

The purpose of the Corporation is:

A. To erect, construct, establish, purchase, lease and otherwise acquire and to hold, use, equip, outfit, supply, service, maintain, operate, sell and otherwise dispose of inns, taverns, bars, saloons, cocktail lounges and other drinking places and establishments of every kind and description, and generally to conduct the business of a bar or tavern and as a dispenser of drinks and alcoholic beverages, and to engage in all activities incidental or relating thereto.

B. To engage in any activity or business permitted under the laws of the United State or of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

This Corporation shall have one (1) class of commons stock having a par value of One Dollar (\$1.00) per share and the same shall be fully paid and nonassessable. The maximum number of shares of said stock this Corporation is authorized to have outstanding at any one time is Seven Thousand (7,000) shares.

**ARTICLE IV. CAPITALIZATION.**

The amount of capital with which this Corporation shall begin business if Five Hundred (\$500.00) Dollars.

**ARTICLE V. DURATION.**

This Corporation is to have perpetual existence.

#### **ARTICLE VI. PRINCIPAL OFFICE.**

The initial street address of the principal office of this Corporation in the state of Florida is: 2095 SE Joyner Circle, Port St. Lucie, Fl. 34952.

The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

#### **ARTICLE VII. DIRECTORS**

This Corporation shall initially have one (1) Director. The number of Directors may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but shall never be less than one (1).
