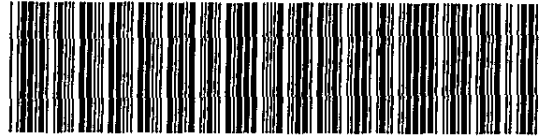



**ARTICLES OF INCORPORATION
OF
EMERALD COAST DECKS & FENCE, INC.**

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**Article I
Name of Corporation**

The name of the corporation (the "Corporation") is **Emerald Coast Decks & Fence, Inc.**

**Article II
Principal Office**

The principal place of business of the Corporation is: 427 Benning Drive, Destin, FL 32541. The mailing address for the corporation is P.O. Box 5107, Destin, Florida 32540.

**Article III
Authorized Shares**

The maximum number of shares the Corporation is authorized to issue is 1,000, all of which shall be Common Shares, with a par value of \$.01 per share. 
