

ARTICLE I [CORPORATE NAME]

The name of this corporation is MAS VELOZ PUBLISHING CORPORATION.

ARTICLE II

ITERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III

INATURE OF BUSINESS & POWERS!
