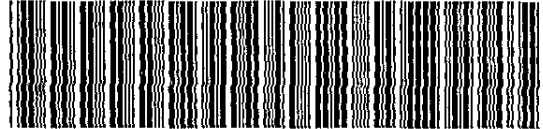

The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a Corporation for profit under the laws of the state of Florida.

*ARTICLE I - Name*

The name of the corporation is **Inzi Distribution Corp.**

*ARTICLE II - Principal Office*

The street address of the initial principal office of the corporation is **8516 Old Winter Garden Road, Suite 204, Orlando, FL 32835**, and the mailing address of the corporation is 8516 Old Winter Garden Road, Suite 204, Orlando, FL 32835.

*ARTICLE III - Capital Stock*

The maximum number of shares of stock that the corporation is authorized to issue is **100 shares** of common stock having par value of **one (\$1.00) dollar** per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

*ARTICLE IV - Preemptive Rights*

Every Shareholder, upon the sale of any additional stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

*ARTICLE V - Initial Registered Office and Agent*
