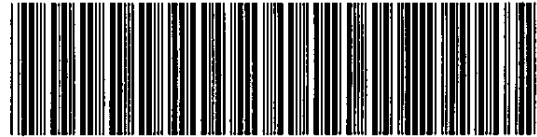

ACCORDINGLY, we have executed these Articles of Amendment on this 9th day of May, 2006.

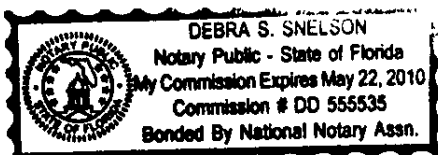
