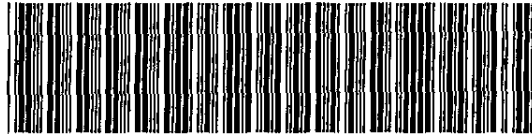

ARTICLE I


