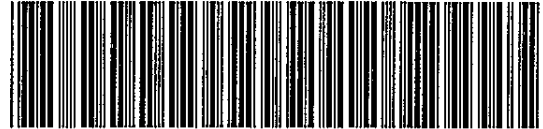

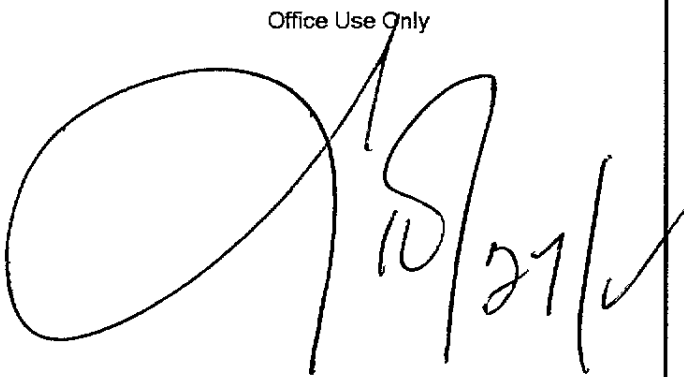

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

THE NAME OF THIS CORPORATION IS:

ARTICLE II - DURATION

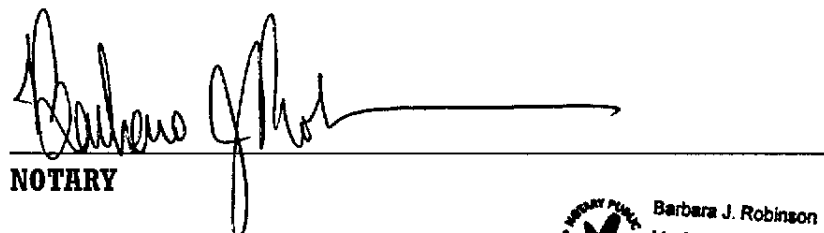

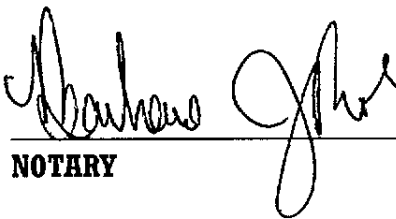
