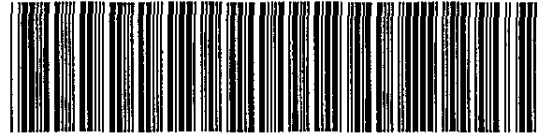

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I. NAME**

The name of this corporation shall be MARTIN COUNTY MARINE CONSTRUCTION, INC..

**ARTICLE II. TERM OF EXISTENCE**

This corporation is to exist perpetually.

**ARTICLE III. NATURE OF BUSINESS**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV. CAPITAL STOCK**



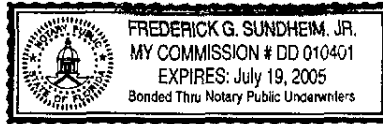
