The undersigned subscribes to these Articles of incorporation, each a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

ARTICLE

NAME: The name of this Corporation is:

HIALEAH DISCOUNT & 99 CENTS SUPPLIES, INC

ARTICLE II

NATURE OF BUSINESS:

- (a) The general nature of the business of the Corporation to be conducted by the corporation shall be trading in various consumer goods.
- (b) To purchase, improve, develop, lease, exchange, sell, dispose of and otherwise deal in and turn to account, real state; to purchase, lease, build, construct, erect, occupy and manage buildings of every kind and oharacter whatsoever; to finance the purchase, improvements, development and construction of land and buildings belonging to or to be acquired by this corporation, or any other person, firm or company.
