ARTICLES OF INCORPORATION
OF
ALEXANDER CONSTRUCTION CONSULTANTS, INC.

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation (the "Corporation") is ALEXANDER CONSTRUCTION CONSULTANTS, INC.

ARTICLE II

The existence of the corporation shall be perpetual and begin on the date of filing these articles of incorporation with the Department of State of the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 1001 South Ridgewood Avenue, Edgewater, Florida 32132.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred thousand (100,000), all of which shall be Common Shares. 
ARTICLE VII
