ARTICLES OF INCORPORATION Z FOODS, INC.

The undersigned subscribe to these Articles of Z FOODS, INC., each a natural person competent to contract, hereby associate them together to form a corporation under the laws of the State of Florida.

ARTICLE I- NAME

The name of this corporation Z FOODS, INC.

ARTICLE II- NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be to buy and sell, import and export foods including but not limited to rice, corn, beef, chicken, flour, (and their associated by-products and derivates) as well as processed\manufactured food products including but not limited to milk, spaghetti, processed meats, and bread.

This may contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required, or to purchase the corporate assets of any other corporation and engage in the same or other character of business. In general, to carry on any other business in connection with the foregoing, and to have and exercise all the powers concerned by the laws of Florida upon corporations formed under its laws and to do any or all things herein before set forth to the same extent as natural persons might or could do.

ARTICLE III- CAPITAL STOCK

The maximum number of shares of stocks that this corporation is authorized to have outstanding at any one time is: five hundred (500) share(s) of common stock with a par value of \$1,00 each.

All the aforementioned stock is to be issued as fully paid for an exempt from assessment. The capital stock may be paid for in money, property, labor, or services, at a just valuation to be fixed by the incorporators or by the Directors at a meeting called for such purpose.

ARTICLE IV- INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is not less Than Five Hundred dollars (\$500 USD).

ARTICLE V- TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI- ADDRESS
