ARTICLES OF INCORPORATION OF ANVIL RENOVATIONS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is: ANVIL RENOVATIONS, INC.

ARTICLE II

This corporation shall engage in the commercial, residential and recreational restoration and any and all lawful business permitted under the laws of the United States or the State of Florida.

ARTICLE III

The street address of the principal place of business of the corporation is: 1380 Dunmire Street, Suite 44, Pensacola, FL 32514.

ARTICLE IV

The existence of the corporation shall begin on the date of filing of these articles with the Department of State.

ARTICLE V

The maximum number of shares this corporation is authorized to issue is 25,000, par value \$1.00 per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

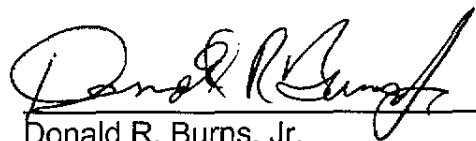

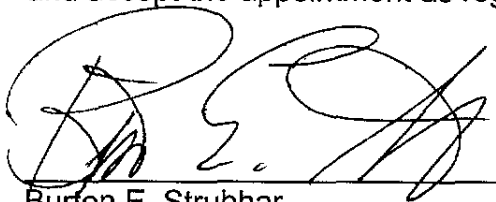
