On this 28th day of October, 2004, the undersigned Incorporator signed these Articles of Incorporation, on behalf of Nancy E. Van Winkle and Philip J. Van Winkle, and presents them for the formation of PJ&N Family Corporation, (referred to as the "Corporation"), a for-profit corporation formed under Chapter 607 of the Florida Statutes, with reference to the following facts:

ARTICLE I.




