ARTICLES OF INCORPORATION OF ROBERT TITUS ENTERPRISES, INC.

The undersigned incorporator, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME
