of

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation in accordance with the laws and state of Florida.

**Article I. – Name**

The name of this corporation is Patricia Rich Behavior Analyst, Inc.

**Article II. – Nature of Business**

The general nature of the business to be rendered by this corporation is any lawful purpose permitted by the laws of the State of Florida.
