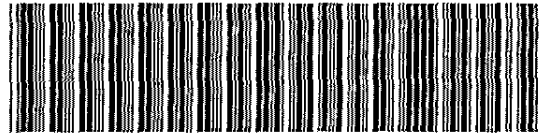

ARTICLES OF INCORPORATION  
OF

KNOW ALL MEN BY THESE PRESENTS:

THAT WE THE UNDERSIGNED, **DONALD SANDERS AND JOYCE SANDERS** DO HEREBY DECLARE AND AFFIRM THE INTENT AND PURPOSE OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, AS FOLLOWS:

ARTICLE 1

THE CORPORATION HEREBY PROPOSED TO BE ORGANIZED SHALL BE NAMED AND KNOWN AS **S&S ENTERPRISES ALLIANCE INCORPORATED**. BY WHICH NAME IT MAY CONTRACT AND BE CONTRACTED WITH, SUE AND BE SUED, ADOPT A CORPORATION SEAL, AND DO ALL THINGS NECESSARY TO CONDUCT ITS BUSINESS IN THE FURTHERANCE OF ITS EXPRESSED PURPOSE.

ARTICLE 2

THE PURPOSE AND NATURE OF THE BUSINESS WHICH IS TO BE TRANSACTED, PROMOTED AND CARRIED ON BY THIS CORPORATION SHALL BE CONDOMINIUM GUEST SERVICES, THE ACQUISITION OF LAND, COAL AND OTHER MINERAL RIGHTS, EITHER BY PURCHASE OR LEASE, THE CONTRACTING OF CONSTRUCTION OF BUILDINGS UNDER THE LAWS OF THE STATE IN WHICH CONTRACTS ARE MADE, THE PRODUCTION OF OIL, COAL, AND OR ANY OTHER MINERAL ON ANY PROPERTIES LEASED OR PURCHASED, THE PURCHASE OF PRODUCTS JEWELRY, OR OTHER PRODUCTS, TO RESALE WITH CORPORATE OR NON CORPORATE COMPANIES, INDIVIDUALS AND OR GROUPS, FOR THE PURCHASE, SALE, DEVELOPMENT, AND TRANSPORTATION OF SAME, AND TO HOLD, SELL, DISPOSE OF, PLEDGE, OR MORTGAGE ANY PROPERTY, REAL OR PERSONAL, AS MAY BE NECESSARY IN CARRYING OUT SUCH PURPOSES, SUBJECT TO ANY LIMITATIONS PRESCRIBED BY LAW; AND TO DO ALL THINGS NECESSARY AND DESIRABLE TO PROTECT OR ENHANCE, DIRECTLY OR INDIRECTLY, THE VALUE OF ANY INTEREST OR RIGHT OWNED OR HELD BY THE CORPORATION BY REASON OR ITS EXPRESSED PURPOSES; TO BORROW MONEY, OBTAIN CREDIT, OR PROPERTY, TO MAKE CONTRACTS, TO INCUR OBLIGATIONS, AND OR SECURE THE SAME BY MORTGAGE OR PLEDGE OF ALL OR ANY OF ITS ASSETS; TO ACT FOR OTHERS IN ANY CAPACITY OR MANNER, TO PARTICIPATE WITH OTHER CONCERNS IN ANY

BUSINESS, ENTERPRISE, OR TRANSACTIONS WHICH THE COMPANY OR CORPORATION IS AUTHORIZED TO ENGAGE IN, IN ANY MANNER AND ON ANY TERMS; AND TO DO ANY AND ALL FURTHER ACTS CONSISTENT WITH THE PURPOSE HEREINFOR SET FORTH, AS NOW OR HEREAFTER AUTHORIZED BY LAW FOR A CORPORATION. IT BEING THE INTENTION THAT THE ENUMERATION OF SPECIFIC POWERS SHALL NOT OPERATE TO LIMIT IN ANY MANNER THE GENERAL POWERS CONFERRED UPON CORPORATIONS BY THE STATE OF FLORIDA.

IN GENERAL, TO DO ANY AND ALL THINGS HEREIN SET FORTH TO THE SAME EXTENT AS A NATURAL PERSON MIGHT OR COULD DO WITHIN OR WITHOUT THE STATE OF FLORIDA, EITHER ALONE OR IN COMPANY OF OTHERS, AND TO CARRY ON ANY OTHER BUSINESS IN CONNECTION THEREWITH, AND TO DO ALL THINGS NOT FORBIDDEN, AND WITH ALL THE POWERS CONFERRED UPON CORPORATIONS BY THE LAWS OF THE STATE OF FLORIDA.

#### ARTICLE 3

THE DURATION OF THE CORPORATION SHALL BE PERPETUAL.

#### ARTICLE 4

THE ADDRESS OF THE REGISTERED OFFICE IS 1982 STATE RD. 44 SUITE 159, NEW SMYRNA BEACH, FLORIDA 32168, THE NAME AND ADDRESS OF THE REGISTERED AGENT IS DONALD SANDERS, 1982 STATE RD. 44, APT 159, NEW SMYRNA BEACH, FLORIDA 32168.

#### ARTICLE 5

THE TOTAL NUMBER OF SHARES AUTHORIZED TO BE ISSUED AND THE AUTHORIZED CLASS THEREOF SHALL BE (100) ONE HUNDRED SHARES OF COMMON STOCK OF NO PAR VALUE. THE VOTING POWER OF SUCH STOCK SHALL BE ONE (1) VOTE PER SHARE.

THE SHARES OF STOCK AUTHORIZED TO BE ISSUED UNDER THESE ARTICLES SHALL BE WITHOUT CLASSIFICATION, RESTRICTION, LIMITATION, OR DISTINCTION AS TO THE RIGHTS OF OWNERS.

#### ARTICLE 6

THE MINIMUM AMOUNT OF CAPITAL WITH WHICH THIS CORPORATION SHALL BEGIN SHALL BE (100) ONE HUNDRED DOLLARS.

#### ARTICLE 7

THE NAME AND ADDRESS OF THE INCORPORATOR, IS DONALD SANDERS, AND JOYCE SANDERS, 1982 STATE RD. 44, APT 159, NEW SMYRNA BEACH, FLORIDA 32168.

#### ARTICLE 8

TWO DIRECTORS OF THE CORPORATION ARE TO BE ELECTED AT THE FIRST MEETING OF THE SHARE HOLDERS TO BE HELD AS SOON AS PRACTICAL AFTER ISSUANCE OF THE CERTIFICATE OF INCORPORATION. THE BYLAWS OF THE CORPORATION MAY PROVIDE FOR A GREATER OR LESSER NUMBER OF DIRECTIONS. THE INITIAL BOARD OF DIRECTORS WHO SHALL SERVE UNTIL THE FIRST MEETING OF THE SHARE HOLDERS SHALL BE AS FOLLOWS:

#### ARTICLE 9

THE GENERAL OFFICERS OF THE CORPORATIONS SHALL BE: DONALD SANDERS PRESIDENT, SECRETARY, AND TREASURER, AND JOYCE SANDERS EXECUTIVE VICE PRESIDENT, AND THE BYLAWS MAY CONTAIN PROVISIONS FOR THE CREATION OF OTHER OFFICES AND THE FILLING THEREOF FROM TIME TO TIME AS THE BOARD OF DIRECTORS MAY SEE FIT.

#### ARTICLE 10

THE CORPORATION SHALL BEGIN THE TRANSACTION OF BUSINESS UPON THE ELECTION OF THE FIRST BOARD OF DIRECTORS, BY THE SHARE HOLDERS, THE DESIGNATED AMOUNT OF CAPITAL, AND THE CERTIFICATE OF CORPORATION THEREFORE ISSUED AND DULY FILED WITH THE RECORDS OF INCORPORATION.

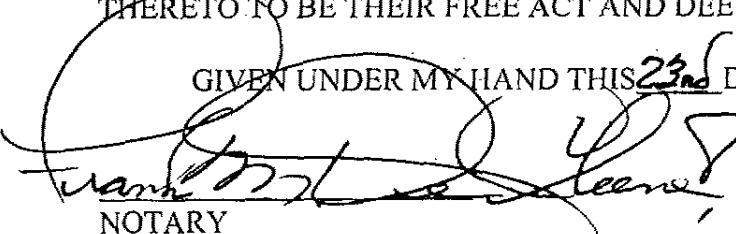
