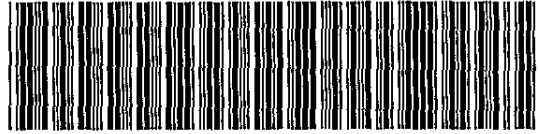

The undersigned hereby forms a corporation under the laws of the State of Florida, and under the following Charter of Articles of Incorporation:

**ARTICLE I**

The name of this Corporation shall be JEBA MEDIA GROUP, INC.

performed for the Corporation, to the fullest extent permitted under Florida law existing now or hereafter enacted.

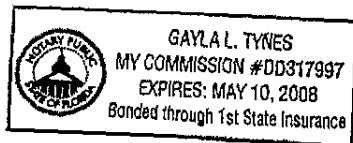


