# ARTICLES OF INCORPORATION OF:

#### ARTICLE I - NAME

The name of this componation is: LUZMA'S CAFE, CORP.

# ARTICLE II - DURATION

This componation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incomponation by the initial subscribers.

#### ARTICLE III - PURPOSE
