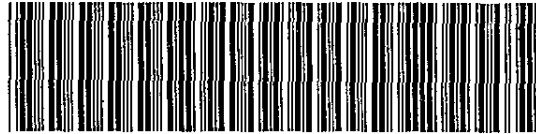




ARTICLE VII
