### ARTICLES OF INCORPORATION OF ACCENT HOME IMPROVEMENTS, INC.

#### ARTICLE I. NAME

The name of this corporation shall be Accent Home Improvements, Inc.

#### ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation. This corporation's duration shall be perpetual.

#### ARTICLE III. PURPOSE

This corporation is being organized for the purpose of engaging in any and all business activities permitted under the laws of Florida and the United States Of America.
