As to the name in box 10 not matching the person signing in box 12, the name in box 10 is misspelled. If you look at the online info you will see that the registered agent name is "Robert C SPIARS" and the name of the officer is "Robert C SPEARS." These two names are the same person, ME. I do not know why my name is misspelled but the correct spelling is SPIARS, the same way I signed in box 12.
