ARTICLES OF INCORPORATION

OF

The undersigned acting as subscriber(s) of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such Corporation.

Article I

The name of the Corporation is: RAPID CAR WASH, INC.
