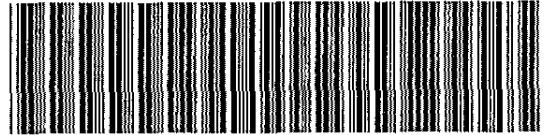

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is BOMAT PROPERTIES, INC., and the principal address and principal place of business is 7663 CARVER COURT, SEMINOLE, FLORIDA 33772-4948.

ARTICLE II - REGISTERED OFFICE AND AGENT
